## Members of Labor Relations Commission

Cases brought to the Labor Relations Commission (LRC) are handled by commission members and by Secretariat staff who assist the members.

Commissions are made up of members representing three parties:

- Public members chosen from academic experts
- Labor members recommended by labor unions
- Employer members recommended by employers' organizations
  In Tokyo, a total of 39 people are appointed as members; 13 people are appointed for each party.

Members appointed from different parties cooperate with each other to handle cases.



# Other activity

## **Determining Eligibility of Labor Union**

When a labor union is filing a complaint against an unfair labor practice or is applying for a certificate to register as a corporation, LRC determines whether the union is eligible (e.g. whether the union is organized and operated independently and democratically).

You will need to submit the union charter and other documentary evidence for eligibility to be determined. Contact us for details on the procedure.




